### WRFC RULES & REGULATIONS

Western Racquet & Fitness Club's child care area is an unlicensed child care providing a bright, clean, and safe environment for your child while you use our fitness facility. Our staff is carefully interviewed and hired so that your kids are supervised by a loving, attentive and responsible person always. We invite you get to know our child care staff and provide feedback or questions at any time.

#### PLEASE INITIAL NEXT TO EACH NUMBERED ITEM INDICATING IT HAS BEEN READ AND IS UNDERSTOOD:

1. \_\_\_ A Childcare Release Form must be signed prior to first visit and every year after. An acknowledgement of having read and received the latest version of the Rules and Regulations must also be signed upon your first visit.
3. \_\_\_ Child(ren) must be at least 12 weeks of age to be admitted. Infants who cannot sit without assistance should arrive in their carrier.
5. \_\_\_ Parents are required to sign their child(ren) in and out at each visit.
6. \_\_\_ Childcare is limited to a 2-hour maximum per child care session. A fee will be charged for every 30 minutes over the 2-hour period, per child.
7. \_\_\_ **Children with any visible signs of sickness will not be permitted.** These symptoms include, but are not limited to the following: runny nose with yellow or green mucus, fever, wet cough, pink eye, rashes, etc. Childcare staff will NOT administer any type of medication unless it is a rescue medication. Ex: EpiPen, inhaler, etc.

8. \_\_\_\_ **If any child is inconsolable for over 10 minutes, parents will be pulled out of class to console your child or may be asked to leave and return later.** This is to ensure an enjoyable experience for other children, staff, and members in the facility.
9. \_\_\_\_ Parents must remain in the facility while children are in the childcare room or club.
10. \_\_\_\_ **Children under 10 are NOT allowed unsupervised in the lobby, hallway or restrooms.**
14. \_\_\_\_ Toys from home are permitted at the staff's discretion. Staff is not responsible for lost, stolen or left behind items. We recommend bringing activities or toys from home for children over the age of 8 if they are not a choking hazard.
15. \_\_\_\_ If diapering is permitted, parents must provide diapers and wipes for their child, along with a change of clothes. Diaper bags must also be labeled with child's name. We will do our best to change diapers but it is not a guaranteed service, due to time limitations or safety of other children being left unattended.
17. \_\_\_\_ If a child has a dirty diaper at the time of entering the childcare room, it is the responsibility of the parent to change the diaper before he /she leaves to work out. Only diapers that become wet or soiled while the child is in the care of the staff will be changed.
19. \_\_\_\_ If your child is potty training, please notify the staff during sign in and bring a change of clothes in case of accident.
20. \_\_\_\_ Childcare staff will use only verbal reprimand for inappropriate behavior or language. Several warnings may result in the parent being called in. If child is unable to regain proper behavior, the child and parent will need to leave for remainder of the day. This is to ensure the safety of the other children, members and staff. Examples of inappropriate behavior include but are not limited to the following: hanging from, climbing on, or jumping off furniture; banging on walls or glass; hitting or biting other children or staff; coloring on walls, furniture, or carpet, bullying, talking about inappropriate things.
